By signing below and by using our facility, you agree to the terms set forth below. You understand we are an independently owned and operated franchise and you are not entering into a relationship with our franchisor, Fit Body Boot Camp, Inc.

STANDARD \$200 ENROLLMENT FEE: Applies to all membership programs.

12 WEEK LOVE YOURSELF COMMITMENT: We believe strongly in the Fit Body Boot Camp Unstoppable Fitness Formula and we take your satisfaction very seriously. By signing below, you are committing to join the Fit Body Boot Camp Fitness Family for a minimum of 12 weeks.

LOVE IT OR LEAVE IT GUARANTEE: You may cancel this agreement at any time before your trial expires without penalty by emailing **XX-EMAIL-XX**.

ELECTRONIC FUNDS TRANSFER (EFT): This is a legal contract. After the trial membership offer, you agree to be automatically billed each week for the amount specified and duration specified above. After the initial term, membership will continue, week to week, unless and until you cancel through the cancellation process included in this document.

CANCELATION: You may cancel at any time for any reason by requesting a cancellation notice via email to **XX-EMAIL-XX**. In response to your notice, you will be sent the official electronic cancellation form. Membership and payments will continue until the electronic cancellation form is completed and submitted. Regardless of when you submit the official electronic cancellation form, you would be liable for the greater of (a) the remainder of the first 12 weeks or (b) 4 weeks from the date the completed form is submitted. In other words, if you cancel during week 3, you would owe nothing more than the payments for the initial 12 weeks. If you cancel in week 11, you would be liable for the next 4 weeks. You authorize us to process payments consistent with the foregoing.

Paid in full agreements are non-refundable and non-transferable due to the substantially discounted pricing.

FREEZE OPTIONS: We may allow you to freeze your membership for a limited time due to medical issues upon receipt of a note signed by a medical doctor submitted before the requested freeze date and clearly state that you cannot exercise safely and the expected duration of your absence.

I understand I cannot be credited a freeze (no refunds) if I notify Fit Body Boot Camp after payment has been drawn. In order to freeze my account (medical freeze) I must email **XX-EMAIL-XX** prior to the requested freeze date with a signed doctor's note, otherwise freeze will not be granted. Membership Suspension of any kind does not release me from the agreed upon 12 week commitment.

FACILITY UPGRADE & EQUIPMENT FUND: Annual **\$25-\$50**. Fee processed on April 1 of every year.

DECLINED PAYMENTS: Declined credit cards or non-sufficient funds (NSF) are subject to a \$15 fee.
